A MESSAGE FROM AIA ARKANSAS PRESIDENT THAD KELLY

This has been an exciting political year, and it is not over yet. Although federal elections are held every other year, the campaign for the presidential seat brings a higher level of excitement. I hope to see more enthusiasm about the political process from our Institute. We need more AIA Arkansas Architects to show interest and commit to serving in office. This does not mean just in national, state or city positions. We need AIA Arkansas candidates to take leadership roles on city boards, as well as city and county commissions. At the very least, get involved in a political campaign. It is fun, appreciated, informative and brings civics lessons to life.

Speaking of politics, several things are in the works that you should know about. The State Board of Architects' executive director has met with Sen. Percy Malone about the 2009 legislation that will combine Interior Design, Architects and Landscape Architects into one Board of Design. On the UA campus the conversation between both Advisory Boards and both Deans has been initiated to relocate the Interior Design program into the School of Architecture and Landscape Architecture.

INTERNS, the State Board of Architects has voted to follow NCARB and allow ARE testing in concurrency with your IDP training. THIS WILL HAPPEN IN EARLY 2009!!! There are several processes that must happen for this to OFFICIALLY be enacted. One is for a publication of the changes to the Rules and Regulations with Public Hearing. Both the combined Board of Design and the ARE/IDP concurrency will be at the same time. Mark your calendar for first quarter 2009! Good Luck! As a further help to Interns, the six-month reporting deadline will also be in effect sometime in 2009 or 2010 depending on your status as an IDP intern. This reporting deadline will only help you and is not punitive. Trust me, Architects never do anything without a real deadline!

At the Gulf States Regional workshop R. Allen Eskew, FAIA and Lee Askew, FAIA presented the road to AIA Fellowship. Our own past president Gordon Duckworth, AIA attended as "AIA Arkansas Chapter's Mentor." Look for his article elsewhere in

this issue of Columns. Gordon has graciously volunteered to help the many deserving AIA members to become Fellows of the AIA.

In 2007 Galen Hunter appointed me to chair a committee to bring to UA Facilities Management, AIA Arkansas Architects' feelings, concerns and disappointment with their Lum N' Abner bias against Arkansas-based architectural firms. We have pursued changing the University's selection process. We have had many meetings and audiences. In January AIA Arkansas will give a report of where we are and where we are going in the UA Architect selection process.

The 2008 AIA Arkansas Convention in Hot Springs is fast approaching. There are wonderful offerings for all of AIA Arkansas' members. The convention committee has worked very long and hard to bring value and quality to all of the aspects of this year's convention. Please thank these VOLUNTEERS for their time, talent and tireless devotion to bettering AIA Arkansas' Convention. As always, if you ain't growing you are dying! The AIA Convention is growing and with the online registration, signing up for events, etc., there will be some opportunities for improvement. ## Musco Lights Contribute to Nationals Park LEED Certification

President Bush threw out the first pitch in front of a sold-out crowd at the new \$611 million Washington Nationals Park on March 30<sup>th</sup> — under Musco's Green Generation Lighting®.

The Nationals chose Musco to help them achieve their goal of becoming the first Major League Baseball stadium to achieve U.S. Green Building Council's Leadership in Energy and Environmental Design (LEED) certification. ## Gulf States Region Honors 13 Projects, Including Blackwell's 'L'-Stack House



The Marlon Blackwell Architect firm of Fayetteville received an Honor Award as the AIA Gulf States Region celebrated the 2008 Honor Awards in Boston during the annual AIA Convention.

A nationally recognized jury deliberated more than 157 submittals and chose 13 projects for awards. The Chicago-based jury – John Ronan, AIA, principal, John Ronan Architects; Curtis Sartor Jr., Ph.D., NOMA, Judson University Architecture Department chair; and Heather Salisbury, AIA, senior associate, Valerio Dewalt Train Associates – remarked on the overall quality of work and commended the diversity of project types and solutions.

Architects from each of the region's five states (Alabama, Arkansas, Louisiana, Mississippi and Tennessee) garnered awards.

*Project:* 'L'-Stack House; *Architect:* Marlon Blackwell Architect; *Location:* Fayetteville

The house as bridge offers "an intensification of place, a cultured place revealing the evolving relations between home, nature, and city," according to the architect. It is intended to serve as an integral element for a sustainable community. "This project shows a thoughtful response to site, particularly the way the building bridges across the drainage swale," the jury remarked. They also were taken with the project's "striking geometry" and "elegant plans and interior spaces."

## Advanced Energy Conservation Techniques

---

Designing energy friendly structures has become everybody's responsibility for our future. Advantages include reduced pollution, reduced energy costs, improved indoor air quality, building durability and moisture control. A properly insulated and sealed structure reduces wear on heating and cooling system and mechanical maintenance.

The first step is specifying economical products and quality control of installation. If you spent much time on construction projects (as a typical worker) you would see that fiberglass batts are poorly installed by sheetrock or metal stud crew's general laborers. Correcting this problem will require specifying cellulose or foam. Cellulose is very inexpensive and can reduce overall utility costs by as much as 35 percent. This will take the responsibility out of sheetrock crews and metal stud crews where quality is based on the daily attitude of their lowest paid day laborers. Independent third-party tests have proven that up to 35 percent energy reduction is possible with properly installed cellulose. Many independent tests support this fact such as the Colorado Report, the National Thermal Performance Institute, the Leominster Housing Authority and the Kansas Weatherization Assistance Program. These results and more are available at the Cellulose Insulation Manufacturers Association ([cellulose.org](http://cellulose.org)).

Overall energy reduction can be improved more much with proper air sealing. This can be achieved very cost effectively; the owner will usually recoup the additional cost of cellulose and seal systems in two to three months in utility savings (depending on season). These standards are being promoted by governmental organizations such as the U. S. Department of Energy ([eere.energy.gov](http://eere.energy.gov)), EnergyStar ([energystar.gov](http://energystar.gov)), Building Energy Codes Resource Center ([resourcecenter.pnl.gov](http://resourcecenter.pnl.gov)) and the Oak Ridge National Laboratories Building Technology Center ([ornl.gov/sci/btc](http://ornl.gov/sci/btc)).
