Summer is here already! We are seven months into the year and roughly two months away from the 2005 AIA Arkansas State Convention in Hot Springs, September 29th, 30th and October 1st. We have just recently completed a fabulous AIA National Convention. As you might expect, your AIA Arkansas Board of Directors, Executive Director and staff, and Convention Committee are working diligently in these areas and more to represent you well.

Let me begin by taking this opportunity to make the entire membership aware that this past Spring our own H. Price Roark, AIA of Roark, Perkins, Perry Yelvington, P.A. was honored at the annual banquet of the Associated General Contractors organization being inducted into the Arkansas Contractors Hall of Fame. Mr. Roark is a past President of AIA Arkansas in 1971 and has been a committed and involved member throughout his architectural career. It is with apology that this announcement comes a little late on my part; however, it is never too late to congratulate such a well deserved figure from our organization in this accomplishment. School of Architecture Renovates Vol Walker Hall

The buzz of creativity is palpable within Vol Walker Hall, where students sketch, program, and build around the clock. Built in 1935 as the University of Arkansas library, Vol Walker Hall has been the School of Architecture's home for 25 years. The building was placed on the National Register of Historic Places in 1992.

Recent public and private support has spruced up Vol Walker in preparation for many more years of service. Thanks to a \$500,000 grant from the Arkansas Natural and Cultural Resources Council (ANCRC), a new roof was installed and the exterior limestone was completely restored and cleaned in 2004. Foundation waterproofing and grading work eliminated partial flooding of the basement that occurred after heavy rains, while the building's original skylights, restored in 2003, bathe the second floor gallery in natural light. A \$300,000 gift from Ken and Linda Shollmier funded the modernization of the School's large lecture hall with the latest

audiovisual equipment, new blinds and new cork flooring.

A second ANCRC grant of \$821,000 has funded current work to improve egress from the building. New stairways have been built in the east ends of the office wings just west of the former reading rooms (now design studios and the auditorium), providing additional exits from these large rooms on both the main and second floor. The grant also funds a new exit door at the north end of the basement level. A third ANCRC grant of \$800,000 will improve circulation and egress from the former library stacks located in the western part of the building.

The University is funding the addition of a third story above the office and classroom wings that flank Vol Walker's gallery spaces. The addition will include five new offices that will replace the three removed to create new exits, and will provide additional studio and classroom space.

persons eligible and deserving of our awards. The selected award winners will be recognized appropriately at the 2005 AIA Arkansas State Convention during the Design Awards Banquet. AIA Arkansas recognizes deserving individuals for three awards: Fay Jones Gold Medal Award, Dick Savage Memorial Award and Award of Merit. Please get your nominations in as early as possible.

The AIA National Convention was a huge success. The Las Vegas Convention broke all attendance records and provided programs, tours, and a venue that was attractive and interesting to everyone. The results of the officer elections during the convention were consistent with the AIA Arkansas voting preference. The 2007 national AIA President, three of the four Vice-Presidents and the Treasurer were all positions supported by our organization. It is our belief that from this group of leadership the National AIA will remain in good standing; continuing the progress that recent predecessors at National have made in many areas over the past few years.


We are currently working with the Regional AIA Component, Gulf States, to review and make recommendations to an updating of the Regional by-laws. The current President of Gulf States, Doug Ashe of Louisiana, has been working for two years on this project. He has at last reached a point at which he has submitted the update for review and comment before being presented for a vote in January. The most dramatic change is in the way that the rotations for the two Regional directors are selected. Currently, the rotation is based on the number of members a state held in 1988 (the last time the by-laws were updated). This approach stipulated that Alabama and Tennessee rotated for the first director and Arkansas, Louisiana and Mississippi rotated for the second director. The current proposal stipulates a straight rotation between the five states. Due to the existing equality of membership between the five states, AIA Arkansas is in favor of the this new proposal and is being vocal about the importance of our state having representation on the

Regional level equitable with the other states with whom we have more equal membership numbers. Please feel free to write comments in support of this issue to Brent Stevenson or myself; so that we might forward these comments to the Regional level indicating the importance of this issue to our membership.

Finally, I would be errant in making a report in this newsletter without mentioning the upcoming 2005 AIA Arkansas State Convention. This year's convention is going to be unlike any other. We are introducing a golf outing to start the convention, introducing dual track style seminars in an effort to give the membership greater choice of speakers, introducing student and associate specific programs, and introducing the first Art in Architecture exhibit with the opportunity for our membership to premier their artistic talents outside the realm of architecture to the rest of our profession. In addition to these new additions to the format, we are excited about the speakers that have been selected and the design awards that are being prepared for jury. This year's Convention Committee has been working extremely hard. Please thank them for their hard work when you see them: Convention Chair/ Thad Kelly; Design Awards/ Chad Young; Speakers/ Mark Cahoon and Anthony Taylor; Golf Outing/ Thad Kelly and Craig Boone; Graphics/ Jerry Brackett; Associates Events/ Andrijana Pavlovich; University of Arkansas Faculty and Students/ Thad Kelly and Tim DeNoble; Art in Architecture Exhibit/ Jerry Brackett and Tad Price and Facilities/ David French.

Important Announcement for ARE Candidates

During the 2004 NCARB Annual Meeting and Conference, a majority of NCARB member boards approved the establishment of a "rolling clock" for ARE candidates. At this time, a five-year rolling clock is scheduled to be implemented beginning in January 1, 2006. A series of transitional steps will be in place to best accommodate candidates.

In order to anticipate candidate inquiries about this new standard, the Council is providing a list of "frequently asked questions" that will be updated on a regular basis. An initial question has been distributed to all member boards and is provided below.

Why is a rolling clock being instituted for the ARE?

After two years of study, NCARB's Procedures & Documents Committee decided to require that all divisions of the ARE be passed in a reasonable amount of time. Committee members reviewed the historical changes to the exam, the requirements of those Member Boards that currently have rolling clock provisions, similar requirements in other professions, and related content validity information provided by the Chauncey Group and ultimately determined that a five-year eligibility period was most appropriate for this new national standard.

By implementing a rolling clock, NCARB Member Boards have strengthened the validity of the ARE, as the exam continues to evolve in terms of content, format, and administration. A rolling clock acknowledges such changes and further ensures the public that new registrants have attained those competencies necessary for independent practice.

The press can search the database by a variety of criteria—project type, location, budget, or stage. They can also sign up to receive e-mail alerts when news of a particular type is added to the site and can store news releases in private folders for later access.

Firms can either post existing releases or, through an easy-to use-interface, build a release, including images. When one of its releases is opened, the user is given access to all of the firm's news in one handy index.

State Board Adopts Rule Changes

Effective June 1st, 2005 several rule changes went to affect that will impact all Arkansas architects. The board formulated the rule changes at the February 2005 meeting of the Arkansas state board of architects.

In section one the board redefined the terms "emeritus architect", "responsible control", and "technical submissions". In sections three and five, architect registrations and registrant application standards were amended. Continuing education standards and sanction changes were addressed in section four.

Section eight revised the organizational practice guidelines regarding practicing architecture in a corporation. Section nine changed several aspects of the code of professional conduct. It especially highlighted areas of amended contracts, and construction administration.
