# Polk Stanley, UACDC earn AIA Institute Honor Awards

Four Arkansas projects were among 28 recognized nationally as 2008 recipients of the AIA Institute Honor Awards, the profession's highest recognition of works that exemplify excellence in architecture, interior architecture and urban design. Selected from over 800 total submissions, the 28 recipients will be honored in May at the AIA 2008 National Convention and Design Exposition in Boston.

The Arkansas winners included an Honor Award for Architecture for the Heifer International World Headquarters in Little Rock, Polk Stanley Rowland Curzon Porter Architects of Little Rock, and three Honor Awards for Regional and Urban Design for projects from the University of Arkansas Community Design Center.

## *2008 Institute Honor Awards for Architecture*

The 2008 Institute Honor Awards for Architecture recognize 13 unique projects. The types of projects range from museums and arts centers, to trend-setting residential projects. These projects, which span the U.S., Canada, the U.K. and South Korea, spotlight sustainable building practices and distinguished architecture.

The Heifer International Headquarters is designed as a series of ringed bands that radiate outward. Its narrow corridors ensure that all offices have access to natural sunlight, and a bevy of green features earned the design a spot on the AIA Committee on the Environment's Top 10 Green list and LEED® Platinum certification.

## *2008 Institute Honor Award for Regional and Urban Design*

Five projects were selected to receive the 2008 Institute Honor Award for Regional and Urban Design. The University of Arkansas Community Design Center won three of the five awards in this category, displaying an unprecedented concern and devotion for improving the quality of their urban environment.

Urban growth from the surrounding campus is disrupting a stream's ecosystem and causing erosion, flooding, groundwater pollution and the loss of aquatic life. Ranging from small arrays of "hydrology pixilation" of streams and wetlands to a large "total marsh," each "hydroscape" proposal uses the purifying processes of natural streams and wetlands to rehabilitate the site.

Habitat Trails is a residential low-impact development (LID) consisting of 17 dwelling units for a nonprofit affordable housing provider committed to detached housing. The five-acre development incorporates LID technologies and a range of conservation planning strategies supportive of unit clustering that preserves a third of the site as commonly held open space.

Northwest Arkansas (NWA) is the nation's sixth fastest growing region and is expected to double in population within the next 15 years. # Architecture students help rebuild Big Easy landmark

## Restaurant serves as social anchor for hard-hit neighborhood



Professor Greg Herman and 19 University of Arkansas architecture students celebrated the holiday season by swinging hammers and ripping up floor joists. The U of A School of Architecture group was in New Orleans Dec. 11-16 to work on Miss Gloria's Kitchen, a local restaurant that had been shuttered since Hurricane Katrina.

Last spring, architecture students redesigned the restaurant from foundation to rooftop. Their proposals for outdoor seating, new signage and other improvements will amplify the restaurant's role as a social anchor for Gert Town, a New Orleans neighborhood struggling to recover from Katrina.

"We plan to carry out strategic demolition and prepare the site for construction - if time permits we may build some of the new interior walls," said Herman. "This blitz build takes us one step closer to getting Miss Gloria back in business."

The students will not receive course credit for the week of heavy labor, just the satisfaction of getting the project a little closer to completion. "We wanted to help people who need it," said Caitlin Stevens, a student from Canon City, Col.

"It will be good building experience for us, too," added Stephanie Bedinghaus, a third-year student from Springfield, Mo.

Polk Stanley Rowland Curzon Porter Architects Ltd. of Little Rock, Temple Shalom of Fayetteville and individuals in New Orleans and Fayetteville provided \$38,600 for the project. An additional \$48,400 is needed to renovate and reopen Miss Gloria's Kitchen.

The weeklong build was financed in part by AIA Arkansas and the students themselves, who raised \$650 for travel expenses by selling tickets for a raffle and silent auction. Prizes were donated by Shine Salon, Renaissance Tans, Jim's Razorback Pizza, Penguin Ed's Barbeque, Qdoba Mexican Grill, the Corner Grill, the Pesto Café, Rick's Bakery and Lokomotion Golf.

Tatu Gatere, an architecture student from Nairobi, Kenya, designed and crafted Lucite key chains etched with the students' design for Miss Gloria's Kitchen. The key chains, which cost \$5, may be purchased by contacting Judy Stone at 479.575.2399 or [jkstone@uark.edu](mailto:jkstone@uark.edu).

Peter Trapolin, a principal with Trapolin Architects of New Orleans whose nephew Daniel Kuehn was on the Arkansas work crew, worked with New Orleans Fine Hotels to secure low hotel rates for the students. University of Arkansas alumnus Casey Adams, who is director of real estate for the New Orleans

chapter of Habitat for Humanity, arranged for the loan of a trailer and tools for the project.

The project to rebuild Miss Gloria's Kitchen was inspired by the December 2005 [Arkansas Summit](#) on the University of Arkansas campus. Organized by a university student group, Re\_Vision, and the architecture service organization Project Locus, the conference brought together 50 designers, engineers, historians and students from across the country to discuss how design schools could help New Orleans.

Participants formed a coalition, [CITYbuild](#), which has launched design-build projects in New Orleans by the University of Arkansas, the University of Kansas, Tulane University, the Massachusetts Institute of Technology and other universities.

The CITYbuild Consortium of Schools recently won the 2007-08 Collaborative Practice Award from the Association of Collegiate Schools of Architecture. CITYbuild will be the focus of a special session at the annual meeting of the association, to be held March 27-30 in Houston.

The project also will be included in a book on the 2007-08 education awards to be co-published by the ACSA and AIA.

# NFRC developing energy-rating procedure for nonresidential fenestration

**M**any states, including Arkansas, have energy codes in place for buildings that reference the independent rating and labeling program developed by the National Fenestration Rating Council (NFRC).

Introduced in 1991, NFRC's residential program has played an important role in efforts to increase the efficiency of the nation's windows in recent years. Improvements in the energy performance of nonresidential fenestration, however, have been less dramatic than in the residential sector.

Nonresidential fenestration systems are often assembled or built on site using separate components, which can make it challenging to rate the energy performance of the finished product. In 2001, NFRC introduced a site-built program for such products.

After evaluating user feedback, NFRC decided to develop a new, alternative method. Known as the Component Modeling Approach, or CMA, this procedure uses the individual ratings of a fenestration product's primary components (glazing, framing and spacers) to determine a single energy performance rating for the entire product. The final rating will appear on a Label Certificate, which will be filed on the construction site.

Using a consensus-oriented approach, NFRC is working with all sectors of the industry – from glass manufacturers and glazing contractors to code officials and architects – to ensure that CMA will be fair, easy-to-use and cost-effective. For example, NFRC solicited input from the American Institute of Architects and other associations on CMA's draft-certification document.

CMA will provide benefits to many stakeholders, including the design community. This program will provide an independent and standardized method for determining the energy performance of nonresidential fenestration products, particularly useful for bids and estimates. Using an online library of approved components, architects will be able to simulate design changes to learn how they affect energy performance. In addition, CMA allows the party responsible for the energy performance of a building's fenestration products to prove that the products are provided as specified in the construction documents.

Other stakeholders also will benefit from this new approach. Manufacturers will be able to show architects and specifiers that their products meet energy codes and bid specifications. CMA also will help engineers more accurately determine a building's energy performance. And, the program will help building officials enforce local and state energy codes for fenestration.

Prepare feasibility studies (including flood plain review), space planning and programming, and cost estimates for proposed construction projects or renovation projects. Inspect existing facilities for compliance with the Arkansas Fire Prevention Code and suitability for use by state agencies. Complete reports of findings and take necessary actions to correct deficiencies. Consult with public officials, consulting engineers and architects concerning recommendations for design modifications of projects. Performs related responsibilities as required or assigned.

**Minimum Qualifications:** Licensed as an Architect by the Arkansas State Board of Architects. Other job related education and/or experience may be substituted for all or part of the basic requirements upon approval of the Qualifications Review Committee.
